SRP 3 LEGISLATIVE REPORT FOR OCTOBER 2016

Grants Administrator Judy Fry provided an update regarding meetings that Executive Director Len Engel and Chief Administrative Officer Norm Hickling attended with key legislators while in Washington, DC. Vincent Wiraatmadja, Associate from Weideman Group, who represents AVTA in Sacramento, introduced members from the Air Resources Board (ARB) Advanced Clean Transit Rule Staff: Yachum Chow, Manager and Fang Yan, Air Resources Engineer – Zero Emission Truck and Bus Section; and Shirin Barfjani, Air Pollution Specialist – Heavy Duty Diesel Implementation Branch. The staff members spoke about the group's heavy-duty vehicle electrification program and toured the facility to see AVTA's progression from a diesel fleet to an all-electric bus fleet. The Board discussed various grant opportunities and potential partnerships that would assist AVTA with funding its electric bus project, the next Transportation Special Session, and Cap and Trade program.
